#### **Terms and Conditions for Marine City Farmers Market**

#### 1. Eligibility and Vendor Registration

- a. Vendors must be local farmers, food producers, or artisans offering fresh, locally grown, or handmade products.
- b. All vendors must complete the registration process and provide any required documentation (such as proof of product origin or business license) before participating.

#### 2. Market Hours and Setup

- a. The market will operate on Thursdays from 9:00am to 2:00pm, generally starting the first week in July through the first week in October.
- b. Vendors are required to set up their booths no later than 8:30am and are not allowed to pack up until 2:00pm
- c. The City Administration reserves the right to adjust market hours as needed due to weather, holidays, or other unforeseen circumstances.

## 3. Booth Fees and Payment

- a. Vendors must pay the required booth fee in advance as set forth on the application form. Fees are due by 12:00pm the Wednesday prior to Market Day.
- b. No refunds will be issued for cancellation by vendor prior to the market day.

#### 4. Products and Conduct

- a. Only approved products may be sold. Vendors may not sell items that were not disclosed in their registration form
- b. Vendors must maintain clean and safe conditions at their booths and follow all health and safety guidelines as per local regulations.
- c. Vendors are expected to treat customers, other vendors, and market staff with respect, courtesy and professionalism.
- d. Each booth must be supervised by a person who is 18 years or older.

## 5. Liability and Insurance

- a. The municipality is not responsible for any loss, theft, or damage to products or personal property.
- b. Vendors are encouraged to obtain their own insurance for liability coverage.
- c. Vendors must comply with all applicable local, state, and federal regulations, including any and all health and safety codes.

## 6. Cancellations and Weather

- a. If the market is canceled due to inclement weather, vendors will be notified as early as possible.
- b. No refunds will be issued for weather-related cancellations.
- c. Vendors may cancel their participation by notifying the City Clerk or Deputy Clerk at least three (3) before the market. No refunds will be provided.

## 7. Market Rules and Regulations

- a. The City reserves the right to remove any vendor for violating market rules or any local codes/ordinances.
- b. Vendors must keep their booth area clean and free of waste, disposing of trash properly.
- c. Smoking and alcohol consumption are prohibited within the market area.

#### 8. Amendments

The City reserves the right to amend or change these Terms and Conditions at any time. Vendors will be notified of any changes in writing.
